

- Certification Database Interface (CDI) v1.1
 - Added product shipment resources.
 - Final committee vote scheduled for October 16 followed by GSA board process review and then member vote.
- Third-Party Game Interface (TPI) v2.0
 - Lots of additions and improvements based on initial implementations of TPI v1.0.
 - Expect to have an initial draft in early 2020.
- Regulatory Reporting Interface (RRI) v1.0
 - Evolving to include more types of games, including land-based games.
 - Trying to stay aligned with the work in Europe to develop a standard for online gaming (CEN TC 456).
 - Expect to have an initial draft in early 2020.




